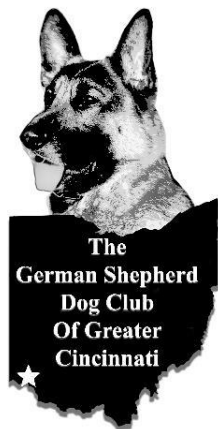

All entry fee checks or money orders (US funds) are to be made payable to CAPER. One check is sufficient for all enclosed entries.

Entries are to be mailed to: **GSDGC/CAPER, 10403 Northwestern Ave, Franksville WI 53126.**

Entries must be received by 6:00 pm Eastern Time Wednesday, May 10th, 2023 after which time no entries may be accepted, cancelled, altered, or substituted. No telephone or verbal entries will be accepted. All changes and cancellations must be received in writing (email is acceptable) prior to closing, except as provided for in Chapter 11, Section 6 of the Rules Applying to Dog Shows published by the American Kennel Club.

All entries must be on official AKC entry forms. Entries will be returned if they are illegible, incomplete, are submitted with incorrect fees, or are photocopied without the reverse side instructions and agreement included. Checks returned for insufficient fees will have the entry cancelled; acceptance of such an entry will only be made if the full fees, plus a \$25 administrative fee, are paid via certified check or money order & received prior to the start of judging. Express deliveries must include signature waiver permitting them to be left at the Secretary's address without receipt signature. **Entries received without signature release will be returned.**

Entries with email addresses will be acknowledged with an email receipt. CAPER is not responsible for non-delivery of emails due to delivery errors or spam blockers, and no further efforts will be made. Confirmations and judging schedules will be sent after closing.

Refunds: Entry fees will not be refunded in the event of errors or cancellation of entries after the published closing date; in the event that a dog is absent, disqualified, excused by the veterinarian or judge, or barred from competition by the Trial Committee; or in the event that extreme weather conditions, riots, civil disturbances, or other acts beyond the control of the Trial Committee make it impossible to open or complete the show/trial. Refunds will be made, less \$5 per entry, for bitches entered in obedience or rally who come into season after the closing date, if notification is made to the secretary at least 30 minutes prior to the start of obedience/rally classes.

Fax/email entries: Entries may be faxed to the Trial Secretary at 262-500-4080, or emailed to secretary@caper-dogs.com. Both the front & back of each entry form must be included, completely filled out and signed, or the entry will not be accepted. Payment can be made via PayPal or credit card by going to: www.caper-dogs.com/PayPalCCpayment.htm and following the instructions there. **Payment must include the \$2.00 per class additional charge to be valid.**

Entry Errors: Exhibitors are responsible for the correctness of entries. All entries which include an email address will be sent an entry verification email shortly after receipt. All errors will be corrected prior to closing; exhibitor errors discovered after closing cannot be corrected. Overpayments of less than \$5 per dog will not be refunded.

SHOW / SITE INFORMATION

The building will be open at 7:30 am each day for exhibitors.

NO SMOKING in the building.

CRATING: An area will be reserved for crating, but space is limited so please plan on stacking crates whenever possible. No X-pens will be allowed. Crates may be left overnight; however, GSDCGC will not be responsible for any lost or damaged items left at the site. No dogs may be left overnight. No unentered dogs are allowed in the building.

LEASHES: Dogs must be on leash on show grounds.

FOOD: No food available on site. There are restaurants in the area.

CATALOG SALES: Donations only.

EXHIBITORS ARE RESPONSIBLE FOR CLEANING UP AFTER THEMSELVES & THEIR DOGS! Anyone witnessed not picking up after his/her dog will be excused from the trial with no entry fees refunded.

CELL PHONES: Please turn all cell phones or pagers to Silent before entering the ring areas.

HOTELS:

- Absolutely no bathing or grooming of dogs in hotel rooms
- Dog owners and agents are personally responsible to any hotel for all damage caused by their negligence
- Dog must be crated in hotel rooms

The club and its agents, employees, etc. will assume no responsibility for any loss, damage or injury sustained by exhibitors or handlers, or to any of their dogs or property, & further assume no responsibility for injury to children.

Exhibitors entering these shows do so at their own risk, understanding that the club will abide by all rules and laws of the city, county, and state.

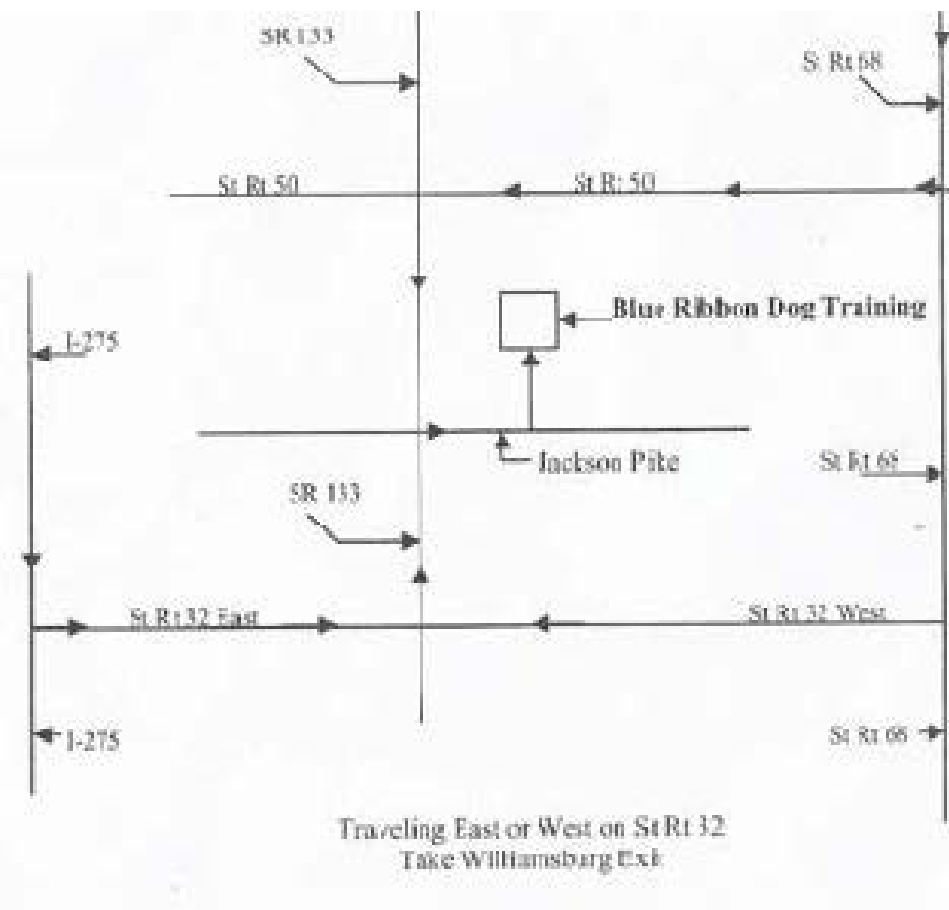
DIRECTIONS TO SITE:

We are located on the eastern side of Cincinnati, convenient to SR 32, SR133, SR68 & I-275.

From I-275: Exit 63B. Exit on SR 32 towards Batavia. Go 13 miles to SR133 (Williamsburg). North (left turn) on SR 133 to Jackson Pike (flashing yellow light). Turn right (East) on Jackson Pike. Location is 1/2 mile on the left.

From the North traveling South on I-71: take exit #50 (SR 68). Turn left on SR 68. Stay on SR 68 until you come to SR 50. (Fayetteville). Turn right and go 8 miles to SR 133.(Williamsburg). Turn left (South) on SR 133 to Jackson Pike (flashing yellow light). Turn left (East) on Jackson Pike. Location is 1/2 mile on the left.

The building sets back off of the road. The grounds are used for tracking and other training. Designated "potty" areas will be marked. Use these areas only to exercise your dogs! And PLEASE pick up after your dogs.

AGREEMENT

I (we) agree that the club holding this event has the right to refuse this entry for cause which the club shall deem sufficient. In consideration of the acceptance of this entry and of the holding of this event and of the opportunity to have the dog judged and to win prizes, ribbons, or trophies, I (we) agree to hold the AKC, the event-giving club, their members, directors, governors, officers, agents, superintendents or event secretary and the owner and/or lessor of the premises and any provider of services that are necessary to hold this event and any employees or volunteers of the aforementioned parties, and any AKC approved judge, judging at this event, harmless from any claim for loss or injury which may be alleged to have been caused directly or indirectly to any person or thing by the act of this dog while in or about the event premises or grounds or near any entrance thereto, and I (we) personally assume all responsibility and liability for any such claim; and I (we) further agree to hold the aforementioned parties harmless from any claim for loss, injury or damage to this dog. INSTRUCTIONS

- (Variety) if you are entering a dog of breed in which there are varieties for show purposes, please designate the particular variety you are entering, i.e., Cocker Spaniel (solid color black, ASCOB, parti-color), Beagles (not exceeding 13 in., over 13 in. but not exceeding 15 in.), Dachshunds (longhaired, smooth, wirehaired), Collies (rough, smooth), Bull Terriers (colored, white), Manchester Terriers (standard, toy), Chihuahuas (smooth coat, long coat), English Toy Spaniels (King Charles and Ruby, Blenheim and Prince Charles), Poodles (toy, miniature, standard).
- The following categories of dogs may be entered and shown in Best of Breed competition: Dogs that are Champions of Record and dogs which, according to their owners' records, have completed the requirements for a championship, but whose championships are unconfirmed. The showing of unconfirmed Champions in Best of Breed competition is limited to a period of 90 days from the date of the show where the dog completed the requirements for a championship.
- (Event Class) Consult the classification in this premium list. If the event class in which you are entering your dog is divided, then, in addition to designating the class, specify the particular division of the class in which you are entering your dog, i.e. age division, color division, weight division.
- A dog must be entered in the name of the person who actually owned it at the time entries for an event closed. If a registered dog has been acquired by a new owner it must be entered in the name of its new owner in any event for which entries closed after the date of acquirement, regardless of whether the new owner has received the registration certificate indicating that the dog is recorded in his/her name. State on entry form whether transfer application has been mailed to the AKC. (For complete rules, refer to Chapter 11, Section 3.)
- Mixed Breed dogs entering classes for Agility, Obedience, and Rally trials should mark Breed as "All-American Dog/ Mixed Breed." Sire and Dam information shall remain blank for mixed breed entrants.
