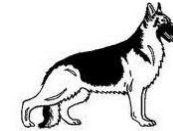

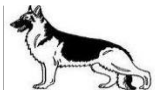

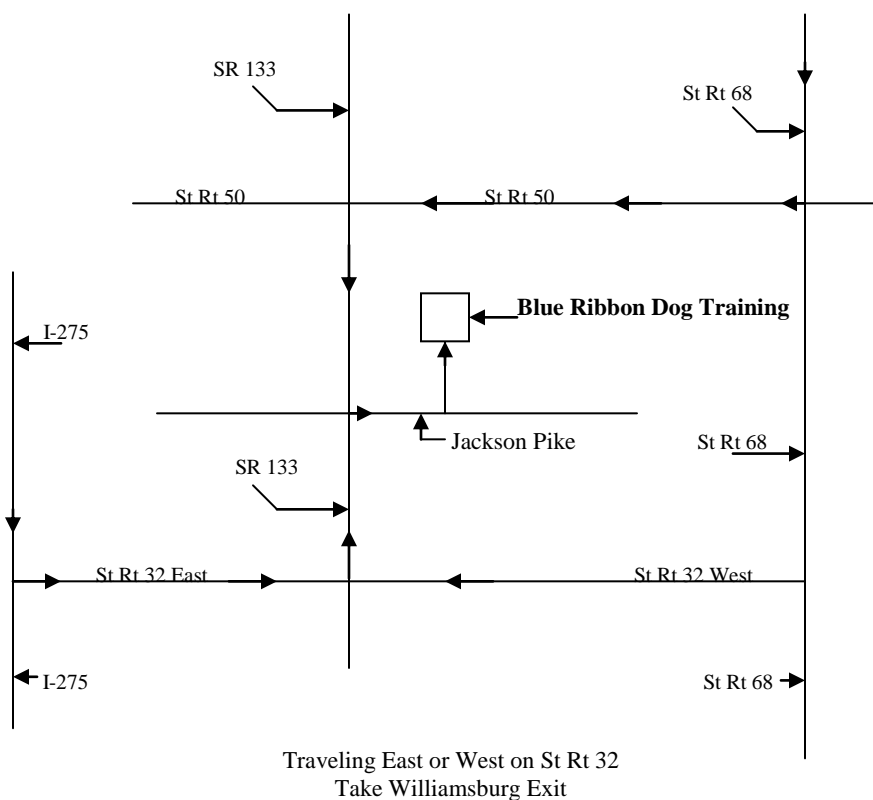
## Directions to the show site

We're located on the eastern side of Cincinnati, convenient to SR 32, SR 133, SR 68, and I-275

**From I-275: Exit 63 (East 32/Batavia) 14 miles to McKeever Road. Turn left.  
Turn Left onto Jackson Pike (there is a detour sign, the road is open to Blue Ribbon). Location is ½ mile on the right.**

**From the North traveling South on I-71 take Exit # 50 (SR 68) turn left on SR 68. Stay on SR 68 until you come to SR 32 (Mt. Orab). Turn right on SR32 to McKeever Road. Turn right then follow directions above.**

**The building sets back off of the road. The grounds are used for tracking and other training. Designated "potty" areas will be designated and marked. Use these areas only to exercise your dogs! And PLEASE pick up after your dog.**
